¹ OSMRE requires each State or Tribe with a Title V Regulatory Program under the Surface Mining Control and Reclamation Act of 1977, Pub. L. No. 95-87, as amended, to submit a current program budget three months prior to the beginning of the Federal fiscal year for which a grant will be requested. OSMRE then conducts a detailed analysis of these program budgets and provides a regional recommendation. No estimates were submitted for OK.

² As authorized by the Full-Year Continuing Appropriations and Extensions Act, 2025 (Pub. L. No. 119-4), the final fiscal year 2025 Regulatory Grant Distribution is \$62,400,000.

³ Consistent with *McGirt v. Oklahoma*, 591 U.S. 894 (2020), and related cases, neither the State of Oklahoma nor any of its agencies are currently eligible to receive development or regulatory grants. *Oklahoma v.
